In collaboration with the Uganda National Bureau of Standards (UNBS), PAU is implementing a strategy for quality assurance during the importation of equipment and materials intended for use in Ugandan oil and gas projects.

Under the PAU PVoC program, equipment and materials must undergo a conformity assessment procedure at the country of origin and be issued with a certificate of conformity (CoC) before importation into Uganda. Conformity assessment will include technical document verification, physical inspection, and sampling and testing in accredited laboratories (where applicable). Conformity assessment will be based on standards and technical regulations approved by PAU and UNBS.

Once a product is proven to comply with applicable standards and technical regulations, it is issued with a Certificate of Conformity (CoC). This facilitates clearance of the certified consignment and allows access to Ugandan markets.
